DISCLAIMER AND INFORMED CONSENT AGREEMENT

I _____ understand that The Lenoir Self(s) Healing Center offers the Self(s) Healing Experience (SHE) both in-person and on the telephone and the objective of SHE is to attain instant enlightenment and find inner peace and calm that presides within me. My system will be aware of and/or disclose on and through many levels of consciousness obstacles that block inner peace within me. Any obstacle that is disclosed through my system or I am cognizant of that contributes to or blocks inner peace and/or a component thereof (e.g. states of worry, stress or feelings of being out-of-control - whatever concerns or is causing stress) that's primed to be outgrown and is blocking inner peace will an integral part of any SHE in-person.

During a SHE in-person, many clients have reported moving past and/or outgrowing out-of-control thoughts or actions and despite that not being the objective of the experience, it is a byproduct that clients report occurs through the SHE in-person. This part of what clients have witnessed is called a 'miracle' because there is no definable explanation of why it occurs: how it exactly occurs is unknown, however one hypothesis is that when inner peace is attained within one's being, false versions of peace are no longer appealing and lose their grip and purpose. A SHE via phone does not include and/or ordinarily produce this byproduct, although randomly it could occur. SHE via phone is a condensed version of a SHE in-person and similar to it in many ways.

ABOUT RHONDA LENAIR

Rhonda Lenoir, also known as Self(s)*, is the invisible representation that mirrors and becomes the non-physically voiced parity of all life, where all life meets at the common point that it is living. Rhonda vocally reflects from her being, not seeing, your life's voice extension. Any life produces information that the life knows it needs to hear to repair and/or be lead to comprehending what is happening on many levels and through many levels of consciousness.

Rhonda Lenoir transforms energy through Self(s) spoken truth that I hear and produce energetically. All of the information I will be subject to comes from my Self(s) (my non-physical being) but relates back to myself (my physical state) through Rhonda Lenoir invisibly and meets my invisible Self(s) where all life complete coexists.

Self(s) is the *energetic counterpart* to the physical self/being that connects and reflects to and through all life complete. Ms. Lenoir becomes my Self(s) reflection and echoes my voiced parity that she re-speaks – in the simplest form, I meet and become judgment-free truth. During the hands-on process, I will feel a slight touch, but not manipulation, on my forehead area by Ms. Lenoir's hands during phase 2 of a SHE in-person. This touch signifies that through Rhonda's hands, you and she are connecting both physically and non-physically during this phase of the experience as one Self(s) being (non-physical) and one self being (physical) in one as a symbolic expression through this gesture.

**Self(s) is an infinite, omnipresent, eternal intelligence and consciousness that presides and seamlessly connects, reflects, and communicates through all creation. Self(s) is where all religions, philosophies, and beliefs that any individual or group mentality subscribe to or belong to, or any school of thought of any kind meets and supersedes any 'minded intelligence' and/or competes with anything separate that is produced physically and/or physical life produces. Self(s) believes that all life that lives IS one life living truth and holds no other opinions, beliefs, philosophies, etc. that are singularized. Self(s) believes that all life if it is living is one seamless part of all life complete. Self(s) believes all life collectively is one life living truth that affects and is affected by all life.
